Memorandum of Understanding about

Linkage for Faculty Exchange/Student Exchange

This Memorandum of Understanding (here in after referred to as MOU) is made and entered into on this day, the 03/07/2023 between DR. PANJABRAO DESHMUKH ARTS AND COMMERCE (EVENING) COLLEGE, COTTON MARKET, SUBHASH ROAD, NAGPUR and RNUKA COLLEGE OF ARTS AND COMMERCE, BESA, NAGPUR for a period of 5 years from the academic year 2023-24 to 2027-28 for Faculty/Student exchange.

1. OBJECTIVES OF THE MOU

- 1. To provide subject expertise to learners of both the institutions
- 2. To provide opportunity to students to interact with their counterparts on curricular, co-curricular and extra-curricular activities

2. PROPOSED TERMS OF COLLABORATION

- 1. Both the institutions shall evolve a mutually acceptable schedule for guest lectures and relieve Of respective subjects for the same.
- 2. Invitation letter for guest lectures shall be given to the teachers at least 15 days in advance.
- 3. Travelling expenses shall be borne by the teachers / students.
- 4. No allowance shall be paid to visiting teachers / students.
- 5. The host institute shall make all the necessary arrangements for the guest lecture

3. NONEXCLUSIVITY

The relationship of the parties under this MOU shall be nonexclusive and both parties are free to pursue other agreements or collaborations of any kind

4. TERMS OF TERMINATION

This MOU, unless extended by mutual written agreement of the parties, shall expire 5 years after the effective date specified in the opening paragraph. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time. Either party shall have the right to unilaterally terminate this MOU upon 60 days' prior written notice to the other party.

5. RELATIONSHIP

Nothing in this MOU shall be construed to make either of the parties a partner, an agent or a legal representative of the other for any purpose. BY SIGNING BELOW the parties, acting through their duly appointed Principals, have caused this Memorandum of Understanding to be executed, effective as on the day and year written above in the first paragraph.
