- 1. The purpose of this Agreement is to develop academic and educational cooperation and to promote mutual understanding between the institutions.
- 2. Both institutions agree and shall endeavor to promote collaborative activities in academic areas of mutual interest on a basis of equality and reciprocity, which shall include but not be limited to the following:
  - a) Exchange of Library resources, reference books and eBooks.

- b) Promoting collaborative cooperation for placement, career guidance, entrepreneurship and start up (Make in India)
- c) Promotion of Curricular and Co-curricular activities.
- d) Exchange of students and faculty development programme.
- e) Conducting competitions, collaborative projects and research activities.
- f) Organizing Students' Seminars and Excursion to create Environmental Consciousness.
- The terms of cooperation for each specific activity implemented under this MOU shall be mutually discussed and agreed upon in writing by both parties in a separate agreement, prior to the initiation of that activity. Any such implementation agreements will form appendices to this memorandum of Understanding.
- 4. The development and implementation of specific activities based on this Agreement will be separately negotiated and agreed between the faculties, schools or institutes, which carry out the specific projects.
- 5. Financial and/or funding considerations shall become the subject of specific discussion and agreement within the framework of a separate implementation agreement. No financial commitment whatsoever, on the part of either signatory to this general document, is intended or implied.
- 6. It is understood that the implementation of any of the types of cooperation stated in clause 2 shall depend upon the availability of resources and financial support at the institutions concerned.
- 7. Should any collaborative research activity under this Agreement result in any potential for intellectual property, both institutions shall seek an equitable and fair understanding as to ownership and other property interests that may arise.
- 8. Each institution shall designate a liaison officer to develop and coordinate the specific activities agreed upon. The designated liaison officers for this Memorandum of Understanding are:
